

NRG Energy, Inc. Announces Redemption of Its Outstanding 7.625% Senior Notes Due 2019

PRINCETON, N.J.--(BUSINESS WIRE)--Apr. 21, 2014-- NRG Energy, Inc. (NYSE:NRG) today announced that it gave the required notice under the governing indenture to redeem for cash all of its remaining 7.625% Senior Notes due 2019 (the "7.625% Notes") on May 21, 2014 (the "Redemption Date"). The redemption price for the 2019 Notes will be 103.813% of the principal amount of the Notes, plus accrued and unpaid interest to the Redemption Date.
