



NRG Energy, Inc. Announces Quarterly Dividend

HOUSTON--(BUSINESS WIRE)--Jan. 20, 2023-- NRG Energy, Inc. (NYSE:NRG) today announced that its Board of Directors declared a quarterly dividend on the Company's common stock of \$0.3775 per share, or \$1.51 per share on an annualized basis. This dividend represents an 8% increase from the prior year, in line with the Company's previously announced annual dividend growth rate target of 7-9% per share. The dividend is payable on February 15, 2023, to stockholders of record as of February 1, 2023.
