This Amendment No. 17 to Tender Offer Statement on Schedule TO (as amended, the "Schedule TO") amends and supplements the statement originally filed on November 12, 2008 by Exelon Corporation, a Pennsylvania corporation ("Exelon"), and Exelon Xchange Corporation, a Delaware corporation and a direct wholly-owned subsidiary of Exelon ("Exelon Xchange"). This Schedule TO relates to the offer by Exelon, through Exelon Xchange, to exchange for each of the issued and outstanding shares of common stock, par value \$0.01 per share (the "NRG common stock"), of NRG Energy, Inc., a Delaware corporation ("NRG"), 0.485 of a share of Exelon common stock, without par value (the "Exelon common stock"). The Offer (as defined below) is made on the terms and subject to the conditions contained in the prospectus/offer to exchange, dated November 12, 2008, as amended on December 23, 2008 and January 23, 2009, and related to the Offer (the "Prospectus"), and in the related Letter of Transmittal (which, together as they may be amended, supplemented or modified from time to time, constitute the "Offer"). Exelon also filed a registration statement on Form S-4 (File No. 333-155278) (the "Registration Statement") on November 12, 2008, as amended on December 23, 2008 and January 23, 2009, relating to the Offer, of which the Prospectus forms a part. The terms and conditions of the Offer are set forth in the Prospectus and the related Letter of Transmittal, which are set forth as Exhibits (a)(4) and (a)(1)(A) hereto, respectively.

All information contained in the Prospectus and the Letter of Transmittal, and any prospectus supplement or any other supplement thereto related to the Offer, is hereby expressly incorporated herein by reference with respect to Items 1 through 11, except that such information is amended and supplemented to the extent specifically provided herein.

The information set forth below regarding Exelon and NRG is incorporated by reference into these Items 1 through 11. The SEC allows Exelon to incorporate information into this Schedule TO "by reference," which means that Exelon can disclose important information to NRG stockholders by referring to another document or information filed separately with the SEC. The information incorporated by reference is deemed to be part of this Schedule TO, except for any information amended or superseded by information contained in, or incorporated by reference into, this Schedule TO. These incorporated documents contain important information about Exelon and NRG and their financial condition.

Item 11(a) is hereby amended and supplemented by adding the following:

On January 30, 2009, Exelon filed with the Nuclear Regulatory Commission ("NRC") an Application for Order Approving Indirect Transfer of Control of Licenses (the "Application") relating to Exelon's proposed acquisition of NRG. The Application was filed in accordance with Section 184 of the Atomic Energy Act of 1954, as amended, and 10 CFR 50.80, "Transfer of licenses," by Exelon acting on behalf of itself and Exelon Xchange, Exelon Ventures Company, LLC, and Exelon Generation Company, LLC ("Exelon Generation"). In the Application, Exelon requests that the NRC consent to the indirect transfer, from NRG South Texas LP ("NRG South Texas") and its corporate parent NRG, of control of the NRC licenses for NRG South Texas' 44% ownership interest in South Texas Project, Units 1 and 2. Exelon has also requested that the NRC consent to the indirect transfer of the NRC licenses for the nuclear stations now owned by Exelon Generation, if NRC approval of such a transfer is required, in order for Exelon to complete its proposed acquisition of NRG through a transaction structure that results in a direct or indirect change of control of Exelon or Exelon Generation, including a transaction in which Exelon merges with and into NRG. A copy of the Application may be obtained in 10 to 14 days through the NRC's Agencywide Document Access and Management System (ADAMS) at www.nrc.gov.
