3. On May 2, 2007, NRG Energy, Inc. announced a 2-for-1 stock split, in the form of a stock dividend paid on May 31, 2007 to all holders of record of Common Stock on May 22, 2007, which resulted in Mr. Cropper's ownership of 12,820 additional shares of Common Stock. The Company?s Common Stock began trading on a split-adjusted basis on June 1, 2007.
