3. Pursuant to the Grant Agreement by and between NRG Energy, Inc. and Mr. Schaefer, the Stock Options will vest and become exercisable as follows: 33 1/3% on January 3, 2007; 33 1/3% on January 3, 2008; and 33 1/3% on January 3, 2009.

4. Stock Options expire six years from the date of grant.
